Proposed Action Description:

The primary objective of Building 9723-14 Disposition is to reduce the overall risk associated with this deteriorating facility, eliminate associated management and operation costs, and reduce the plant footprint. Building 9723-14 has no reportable hazardous materials, therefore, does not require further analysis in an Emergency Planning Hazard Assessment (EPHA) as documented in EMPO-508/HS-140, Hazards Survey for the West End Buildings and Facilities. Building 9723-14 has no reportable radiological materials other than radioactive sealed sources as used by RadCon staff, fixed contamination, etc. which are exempt from EPHA analysis in accordance with DOE 151.1D screening criteria, therefore, does not require further analysis in an EPHA as documented in EMPO-508/HS-140, Hazards Survey for the West End Buildings and Facilities.

The following categorical exclusions (CX) would apply to this action:

B1.3, Routine maintenance (i.e. removal of debris); **B1.23**, Demolition and disposal of buildings;
B1.27, Disconnection of utilities
