Proposed Action Title: **NEPA 4834, rev 4, West End Protected Area Reduction (WEPAR) Project**

Program or Field Office: NNSA Production Office - Y-12 National Security Complex (Y-12)

Location(s) (City/County/State): Oak Ridge / Anderson / Tennessee

Proposed Action Description:

The proposed action is to install a new Perimeter, Intrusion, Detection, and Assessment System (PIDAS) section to reduce the Protected Area of the Y-12 National Security Complex (Y-12) by approximately 50 percent; eliminate the need to maintain the current PIDAS; effectively and efficiently ensure the protection of vital NNSA assets, thus continuing NNSA's nuclear security mission; facilitate cost-effective deactivation and decommissioning (D&D) of process-contaminated facilities; and reduce costs for operations outside the smaller Protected Area. The WEPAR Project would install a new western leg of PIDAS fencing (runs lengthwise along "H" road), upgrade security to buildings that would move outside of PIDAS, upgrade PIDAS alarm sensors and security fencing, install a new vehicle barrier system, and install a new security post for vehicle/pedestrian entrance. The legacy PIDAS infrastructure west of "H" road would be demolished, which would include the removal of fencing, sensors, camera towers, vehicle barriers, and the demolition of Security Post #33. Revision 3 includes: security infrastructure upgrades for additional buildings, a clarification of the project's demolition actions, the installation of temporary mobile trailers to house subcontractor personnel for the duration of the project (reviewed under NEPA 4967), and corrections to the categorical exclusion applied below. Revision 4 adds modifications to the sanitary sewer system within/under the path of the PIDAS work. Plans are in place to modify the sewer system within limitations under existing Y-12 procedures and guidance from Environmental Compliance and Utility personnel.
