## Categorical Exclusion Determination Form

Proposed Action Title: NEPA 5079 - Building 9706-02 Complex Disposition

Program or Field Office: NNSA Production Office - Y-12 National Security Complex

Location(s) (City/County/State): Oak Ridge /Anderson County / Tennessee

Proposed Action Description:

This project is part of the Excess Facilities Disposition Program (EFDP) portfolio. This scope includes Buildings 9706-02 and 9722-02. All utilities will be disconnected, all equipment removed, and all tanks emptied before demolition takes place.

The following categorical exclusions (CX) would apply to this action:

- B1.3, Routine maintenance; B1.23, Demolition and disposal of buildings; and B1.27, Disconnection of utilities

Regulatory Requirements in 10 CFR 1021.410(b):

    - ☐ (iii) Floodplains and wetlands (as defined in 10 CFR 1022.4, "Compliance with Floodplain and Wetland Environmental Review Requirements: Definitions," or its successor);

- ☐ 5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.
