Proposed Action Title: **NEPA 5041 South Ridge Facility Dispositions**

Proposed Action Description:

The purpose of this project is to remove several unoccupied and deteriorating non-process related facilities; thus reducing risk, eliminating management and operation costs, and reducing plan footprint. The specific scope is to disposition Building 9416-24, Building 9949-51, and three 2-million gallon water tanks. Included in this project is sampling for characterization purposes, completion of any remaining utility disconnections, encapsulation and/or abatement of waste or hazardous materials as needed, demolition to slab or grade, waste disposal, and site restoration.
