Proposed Action Title: **NEPA 5060 - Building 9983 Demolitions**

Program or Field Office: NNSA Production Office - Y-12 National Security Complex

Location(s) (City/County/State): Anderson / Oak Ridge / Tennessee

Proposed Action Description:

The purpose of this project is deactivate, demolish, and dispose of six support trailers that were installed between 1993 to 1996. The footprint is being cleared to install 7 modified CONNEX boxes for break areas and storage (please see NEPA 5661). These six temporary structures (Buildings: 9983-BP, -BQ, -BS, -EX-, FC, and 9983-FL) range in size from 170 to 307 sqft each, each has electrical utilities, and were installed on stilts or blocks with no permanent foundation, but with wooden stairs, porches, porch roofs, and other attachments. Deactivation will entail the removal of ancillary attachments, windows, and strappings; all utilities; wall air conditioning units; and the removal of any chemicals (including janitorial). Demolition will not use heavy machinery (these are pre-fabricated structures). No excavation >12 inches is expected.

The following categorical exclusions (CX) would apply to this action:

- B1.3**, Routine maintenance (i.e. removal of debris); **B1.23**, Demolition and disposal of buildings;
B1.27, Disconnection of utilities; **B5.2**, Modification to pumps and piping; and
B1.35, Drop-off, collection, and transfer facilities for recyclable materials.

Regulatory Requirements in 10 CFR 1021.410(b):

- ☐ 5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

Extraordinary circumstances are unique situations presented by specific proposals, including, but not limited to, scientific controversy about the environmental effects of the proposal; uncertain effects or effects involving unique or unknown risks; and unresolved conflicts concerning alternative uses of available resources.

☐ The proposal has not been segmented to meet the definition of a categorical exclusion. The scope of a proposal must include the consideration of connected and cumulative actions, that is, the proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or §1021.211 of this part concerning limitations on actions during EIS preparation.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
